PUBLIC ADVISORY

This is to inform the public and all relying stakeholders of the Professional Regulation Commission (PRC) on the use and acceptance of the digital format or electronic copy of the Professional Identification Card (PIC) (e-PIC), as a valid and sufficient proof of professional identity and standing of the various professionals regulated by PRC.

Beginning 24 February 2023, the e-PIC shall be honored and accepted as a valid government-issued identification document of the professionals for their transactions in all national government agencies and institutions, local government units, and other relevant entities in the public and private sectors, local and international, subject to authentication.

The e-PIC reflects all the information on the physical copy, bearing the name, profession, registration number, registration date, validity period, and a front-facing photograph of the concerned professional.

Verification can be done through PRC Online Verification System Check (online.prc.gov.ph/Verification) wherein the bar code appearing in the e-PIC can be scanned through an internet-enabled computer or mobile device camera.

All concerned entities are enjoined to honor and accept the e-PIC in all its digital forms as proof of professional identity subject to proper authentication and verification.

APPROVING THE e-PIC POLICY AND AUTHORIZING ITS IMPLEMENTATION THROUGH THE LICENSURE EXAMINATION AND REGISTRATION INFORMATION SYSTEM

WHEREAS the Professional Regulation Commission (Commission) is mandated under Section 7 (a) of Republic Act (R.A.) No. 8981 or the "PRC Modernization Act of 2000" to among other things, administer, implement and enforce the regulatory policies of the national government concerning the regulation and licensing of the various professions and occupations under its jurisdiction;

WHEREAS Section 7 (b) of R.A. No. 8981 likewise vests to the Commission the power to issue and promulgate such rules and regulations as may be necessary for the execution and implementation of its functions and the improvement of its services.

WHEREAS, R.A. No. 11032 or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018' aims to streamline or simplify the current systems, procedures and requirements of government services including but not limited to the automation of processes and services, both the internal and external

WHEREAS the Philippine Statistics Authority (PSA) had its proactive strategy in its issuance of the PhilSys digital ID to allow registrants to immediately enjoy the benefits of being PhilSys-registered.

WHEREAS, the Commission has long recognized that information and communications technology (ICT) is a strategic too! in delivering service to its stakeholders and has adopted innovative and technology solutions in various information systems including the Licensure Examination and Registration Information System (LERIS).

WHEREAS, based on the several consultations with various stakeholders, the information and Communications Technology Service (ICTS) through the Systems Development and Maintenance Division (SDMD), recommended the adoption of an electronic copy of the Professional Identification Card (e-PIC) Policy wherein an additional Licensure Examination and Registration Information System (LERIS) module for the viewing and printing of the e-PIC is developed the e-PIC shall be made available immediately after payment of the corresponding fees online:

WHEREAS, under this module the e-PIC (ANNEX A – e-PIC design) can be authenticated and verified through the LERIS Online (online.org gov.ph) profile and/or by scanning the bar code via the PRC Online Vertication System Check (online.prc.gov.ph/Verification) (Annex B – Step by Step Procedure)

WHEREAS, the e-PtC shall have the same validity period with that of the physical copy of the PtC without additional cost to be incurred other than the renewal fee;

WHEREAS. both the e-PIC and the physical copy of the PIC shall be honored and accepted as a valid government-issued identification document of the professional for his or her transactions in all national government agencies, local government units (LGUs), government-owned and controlled corporations (GOCCs), government financial institutions (GFIs), financial institutions and private sector.

WHEREAS the e-PIC is also adoptive to the "new normal" due to COVID-19 and provides a more efficient way of obtaining its digital copy without the need of waiting for the shipping/delivery or pick-up of the physical copy of the PIC,

NOW, THEREFORE, the Commission RESOLVES, as it is hereby RESOLVED, to approve this "e-PIC Policy" and authorize its implementation through the Licensure Examination and Registration Information System

This Resolution shall take effect after fifteen (15) days following the publication in the Official Gazette or in a newspaper of general circulation, copy furnished the U.P. Law Center
