BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROJECT, SUPPLY AND DELIVERY OF NON- COMMON USE SUPPLIES, MATERIALS, AND MATERIALS, AND EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE FOR THE 1st QUARTER OF FY 2024 (EARLY PROCUREMENT) TO "KANON GENERAL MERCHANDISE"

PROJECT : SUPPLY AND DELIVERY OF NON- COMMON USE SUPPLIES, MATERIALS, AND MATERIALS, AND EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE FOR THE 1st QUARTER OF FY 2024 (EARLY PROCUREMENT)

ABC One Million twenty- eight Thousand Seven Hundred Fifty Pesos (Php 1,028,750.00)

WHEREAS, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved the Purchase Request for the above stated project, noting however, that the project is an early procurement, hence, it should comply with the rules provided by the GPPB in awarding the said project;

WHEREAS, the DEP-ED CAR Regional posted the Invitation to Bid in the PhilGEPS, DEP-ED CAR RO, and bulletin boards continuously from October 20, 2023 to November 9, 2023/ 8:31 A.M. and held its pre-bid conference on November 9, 2023/8:30 AM at the Office of the Assistant Regional Director which was attended by prospective bidders;

WHEREAS, pursuant to Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act," and its Implementing Rules and Regulations (IRR), the DEPED- CAR Regional Office through its Bids and Awards Committee (BAC), conducted the opening of bids for the above project on PROVERBS' ENTERPRISES Wangal, La Trinidad, Benguet;

WHEREAS, KANON GENERAL MERCHANDISE and PROVERBS' ENTERPRISES have acquired the bidding documents and punctually submitted its proposals, which was subsequently accepted by the BAC;

WHEREAS, during the bid opening, the findings of the BAC are summarized as follows:

WHEREAS, in view of the foregoing, the BAC proceeded to open the second envelope (bid offers) of **the lone bidder with the following findings:**

WHEREAS, after determining that KANON GENERAL MERCHANDISE was compliant as per initial assessment of the submitted bid, the BAC directed the TWG to conduct bid evaluation;

WHEREAS, TWG members presented their evaluation as follows:

Hence, the ₱4. 00 is to be taken as a discount.	Single calculated bidder

WHEREAS, in view of the foregoing, the BAC directed the TWG to conduct post-qualification evaluation who visited the office address of **KANON GENERAL MERCHANDISE**;

WHEREAS, on November 28, 2023, the TWG presented their post qualification report and found that **KANON GENERAL MERCHANDISE** is a legitimate business and is capable to deliver all the supplies in the procurement project, thus the TWG recommends to the BAC the award of the project to the said Supplier.

NOW, THEREFORE, on the basis of the foregoing, the BAC resolves as it hereby resolved to recommend:

1. To declare that KANON GENERAL MERCHANDISE as the Single calculated and responsive bidder;
2. the award of the contract of the procurement project, SUPPLY AND DELIVERY OF NON- COMMON USE SUPPLIES, MATERIALS, AND MATERIALS, AND EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE FOR THE 1st QUARTER OF FY 2024 (EARLY PROCUREMENT) to **KANON GENERAL MERCHANDISE** with a contract amount of **“One Million TWENTY-TWO**
