BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT OF THE LOT 3 WITH IDENTIFICATION NUMBER 2022-08-006- LOT 3 OF THE PROJECT "SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) LOTS OF VARIOUS INFORMATION COMMUNICATION AND TECHNOLOGY EQUIPMENT AND OFFICE EQUIPMENT FOR THE NATIONAL EDUCATORS' ACADEMY OF THE PHILIPPINES IN BAGUIO CITY TO VRMV TECH SOLUTIONS CORPORATION/ VENN MARK CORPORATION (JOINT VENTURE"

WHEREAS, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request CB 2022-08-006 for the, SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) LOTS OF VARIOUS INFORMATION COMMUNICATION AND TECHNOLOGY EQUIPMENT AND OFFICE EQUIPMENT FOR THE NATIONAL EDUCATORS' ACADEMY OF THE PHILIPPINES IN BAGUIO CITY with the sum Four Million Six Hundred Twenty-Two Thousand Pesos (PhP 4,622,000.00) being the Approved Budget for the Contract (ABC).

WHEREAS, The ABC for Lot 3 is Seven Hundred Forty Thousand Pesos (Php 740,000.00);

WHEREAS, the DEP-ED CAR Regional Posted the Invitation to Bid in the Philgeps, DEP-ED CAR RO Website and bulletin boards continuously from September 16, 2022 to October 11, 2022 at 9:00 A.M. and was opened on October 11, 2022 at 9:05 A.M;

WHEREAS, after the bid opening, the TWG conducted detailed evaluation and was found that the item offered by the bidder is compliant with the required specifications and the bid offer is below the ABC, thus, responsive and was declared as the Single, Lowest Calculated Bidder as follows:
