**BAC Resolution Declaring the Lowest Calculated and Responsive
Calculated Bidder and Recommending Award of Contract on the
Project: Supply and Delivery of Android Tablets**

WHEREAS, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request (PR No. 2022-03-158) for the Supply and Delivery of 333 Units of Android Tablets with the Approved Budget Contract (ABC) of 3,996,000.00 PhP;

WHEREAS, the DEP-ED CAR Regional Posted the Invitation to Bid in the Philgeps, DEP-ED CAR RO and bulletin boards continuously from March 30, 2022 to April 6, 2022 at 1:00 P.M. and held its Pre-bid Conference which was attended by prospective bidders on site and online;

WHEREAS, after the Pre-bid Conference, two prospective bidders bought the bidding documents, however, during the opening of bids on April 19, 2022 at 1:01 P.M. only GAP Import and Export Corporation was able to submit his respective bid proposal;

WHEREAS, the GAP Import and Export Corporation (GAP for Brevity) passed the preliminary examination of bids, and that the BAC found that the bid proposal has substantially complied as follows:

WHEREAS, the TWG recommended that the GAP be declared as the Single, Lowest Calculated Bidder after examining that the legal, technical and financial documents submitted is complete and responsive and that the bid offer is lower than the ABC;

WHEREAS, the TWG proceeded with the evaluation of the quotation vis-à-vis the technical requirements of the project and found as follows:

- a. the offered tablet is bigger and heavier than the published specifications;
- b. The Published chipset is Octa- core (4x2.3 Ghz) & (4x1.8 Ghz) but the offered tablet has a chipset of Octa-core 2.0; 8x2.0 Ghz Cortex- A53

which is lower by .2 ghz though this will not affect the performance of the tablet;

- c. The other specs such as the memory, main camera and battery have higher specifications.

WHEREAS, the TWG recommends that the BAC will decide whether to accept the tablet offered by GAP;

The Post Qualification report by the TWG for the supply and delivery of (the 333 units) Android Tablets is hereto attached as "Annex A"

WHEREAS, the BAC considered that there is no significant effect in the performance of the tablet given that the .2 ghz difference in the chipset is negligible and that all other parts/ component of the tablet such as the memory, main camera and battery have higher specifications.

NOW, THEREFORE, on the basis of the foregoing, the BAC resolves as it hereby resolved, to recommend:

1. To declare GAP Import and Export Corporation to be the Lowest Calculated and Responsive Bid;
2. To recommend for the approval by the DepEd- CAR Regional Director, the award of the contract to GAP Import and Export Corporation the project Supply and Delivery of (333 Units) Android tablets.
