**WHEREAS**, during the scheduled bid opening on December 27, 2021 both PBAJ CONSTRUCTION & SUPPLY, FAMILY CIRCLE CONSTRUCTION, LEO HEIRS CONSTRUCTION, SCA JR. BUILDERS AND HOPE EFG BUILDERS. – were determined to have “Passed” the preliminary bid examination;

**WHEREAS**, the Bids and Awards Committee (BAC) instructed the Technical Working Group (TWG) to do a detailed evaluation of the bids submitted for the above mentioned project;

**WHEREAS**, the TWG did a detailed evaluation of the bids and submitted its report identifying the bid of **PBAJ CONSTRUCTION AND SUPPLY** as the lowest calculated bid and recommended for its post qualification;

**RESOLVED**, this 21<sup>st</sup> day of January, 2022 at DepED CAR RO, Wangal, La Trinidad, Benguet.






