BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF "THE PROVISIONS OF SECURITY SERVICES FOR THE DEPED-CAR REGIONAL OFFICE FOR FY 2023" TO BAGUIO INVESTIGATION AND SECURITY SERVICES AGENCY INC.

WHEREAS, as part of its EARLY PROCUREMENT ACTIVITY, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request CB 2022-10-009 for the, **PROVISION OF SECURITY SERVICES FOR THE DEPED-CAR REGIONAL OFFICE FOR FY 2023** with the sum **One Million Seven Hundred Thousand Pesos (P 1,700,000.00)** being the Approved Budget for the Contract (ABC).

WHEREAS, during the bid opening and the subsequent initial eligibility check on November 16, 2022, the bids were found to be compliant as to its eligibility and technical component and the Financial Documents as well. The Summary of Bids are as follows:
