

2. Clarification on Single Largest Completed Contract (SLCC)

## Concern/Issue

#### The bidder must have completed a single contract that is similar to this project that refer to the Supply and Delivery Sports Supplies and Equipment, equivalent to at least fifty percent (50%) of the

## Clarification Clause

Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period as provided in the Bidding Documents

The bidder must have completed, within the period specified in the Invitation to Bid, an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.

However, in the case of Expendable Supplies, said SLCC must be at least twenty five percent (25%) of the ABC. If, at the outset and after conducting market research, the Procuring Entity can already determine that imposing the same will likely result to: (a) failure of bidding, or (b) monopoly that will defeat the purpose of competitive bidding, the Procuring Entity, in lieu of the above, may require the following:

a) The bidder should have completed at least two (2) similar contracts and the aggregate contract amounts should be equivalent to at least the percentage of the ABC as required above: and

b) The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above.


For this purpose, the similar contracts mentioned under (a) and (b) above must have been completed within the period specified in the Invitation to Bid. The Procuring Entity may clarify in the Bidding Documents the definition or description of what it considers to be a similar project.
