LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**.

**"CA BLISS ENTERPRISES"** a duly registered sole proprietorship organized under the laws of the Philippines with principal office address at ID 29 2nd Floor, Amos Bldng, Km 6., La Trinidad, Benguet represented herein by its Authorized Representative **JOMAR G. BULOS**, herein referred to as the **"SUPPLIER"**

WITNESSETH




