LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the "PROCURING ENTITY"

WITNESSETH

 - Philippine Bidding Documents (PBDs); i.

 - General and Special Conditions of Contract; and iii.
 - Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
