**ROMAN INSTRUCTIONAL MEDIA RESOURCES INC.** a duly registered corporation organized under the laws of the Philippines with principal office address at 36 Anahaw St. Veterans Village, Proj. 7, QC represented herein by **PARALUMAN R. ROBLES**, herein referred to as the "**SUPPLIER**"

#### WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly "SUPPLY AND DELIVERY OF MATHEMATICS LEARNING RESOURCES (MANIPULATIVE MATERIALS) FOR THE DEPED-CAR- Lot 3" and has accepted a Bid by the "SUPPLIER" for the supply of those goods and services in the sum of THREE MILLION SIX HUNDRED SEVENTY NINE THOUSAND NINE HUNDRED TWENTY PESOS(P 3,679,920.00);

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read SUPPLY AND DELIVERY OF MATHEMATICS LEARNING RESOURCES (MANIPULATIVE MATERIALS) FOR THE DEPED-CAR- Lot 3 and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the


