**CONTRACT AGREEMENT**

THIS AGREEMENT, made this \_\_\_\_\_ day of **DEC 27 2023**, 2023 between:

**DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED-CAR)**, a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by **ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director** referred to as the **"PROCURING ENTITY"**.

**"JONECO TECH MARKETING CORP."** a corporation duly organized and existing and by virtue of the laws of the Philippines with principal office address at No. 7 Pioneer St. Cor. Sheridan St. , Elena Roces Compound Highway Hills, Mandaluyong City represented herein by its Representative **EDWIN R. ASUNCION**, herein referred to as the **"SUPPLIER"**

WITNESSETH

WHEREAS, "THE ENTITY" invited Bids for Certain goods and ancillary services, particularly the **SUPPLY AND DELIVERY OF ANDROID TABLETS FOR THE DEPED- CAR** and has accepted a bid by the **"SUPPLIER"** for the supply of those goods and services in the sum of **Ten million four hundred twenty-three thousand and four hundred forty pesos only (P 10, 423, 440. 00)** hereinafter called "THE CONTRACT PRICE".

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. The contract duration or completion period shall be within ***ninety (90) calendar days from the receipt of Notice to Proceed (NTP);***
4. In consideration for the sum of **Ten million four hundred twenty-three thousand and four hundred forty pesos only (₱ 10, 423, 440. 00)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the following goods and services in accordance with his/her/its Bid:

5. The SUPPLIER shall be liable for LIQUIDATED DAMAGES for the delay in its performance in the amount equal to one-tenth of one percent (0.001) of the cost of the goods scheduled for delivery for every day of delay until the goods are finally delivered and accepted by the PROCURING ENTITY. DepEd Shall deduct the liquidated damages from any money due or which may become due to the Supplier, or collect from any warranties or securities posted by the Supplier, whichever is convenient. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
6. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
