**CONTRACT AGREEMENT**

THIS AGREEMENT made this 14<sup>th</sup> day of JANUARY 2022 between **DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED-CAR)** of the Philippines (hereinafter called "the Entity") of the one part and **VENN MARK CORPORATION** of No. 8 Diamond Subdivision, San Luis Village, Baguio City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the office Furniture and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **PHILIPPINE PESO ONE MILLION EIGHTY NINE THOUSAND NINE HUNDRED FORTY TWO PESOS ONLY (Php1,089,942.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

2. The contract duration or completion period shall be Sixty (60) calendar days from receipt of the Notice to Proceed;
3. In consideration for the sum of **PHILIPPINE PESO ONE MILLION EIGHTY NINE THOUSAND NINE HUNDRED FORTY TWO PESOS ONLY (Php1,089,942.00)** or such other sums as may be ascertained, Venn Mark Corporation agrees to provide Labor and Materials for the Structured Cabling for Data Communications and PABX/ Telephone Provisions and CCTV in accordance with his/her/its Bid;
4. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
5. A warranty security shall be required from the contract awardee for a minimum period of three (3) months, in the case of Expendable Supplies, or a minimum period of one (1) year, in the case of Non-expendable Supplies, after acceptance by the Procuring Entity of the delivered supplies. The obligation for the warranty shall be covered by either retention money in an amount equivalent to five percent (5%) of the contract amount, or a special bank guarantee equivalent to five percent (5%) of the total contract price. The said amounts shall only be released after the lapse of the warranty period or, in the case of Expendable Supplies, after consumption thereof: Provided, however, That the supplies delivered are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
