BAC RESOLUTION RECOMMENDING THE AWARD OF THE PROJECT "SUPPLY, DELIVERY, AND INSTALLATION OF THREE (3) LOTS OF OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE" TO HEXACOM ENTERPRISE

WHEREAS, the DEPED- CAR Regional Office, Regional Director/ Head of Procuring entity had approved Purchase Request CB 2022-08-006 for the, **SUPPLY, DELIVERY, AND INSTALLATION OF THREE (3) LOTS OF OFFICE DATA CENTER EQUIPMENT, UPGRADE OF EXISTING CCTV SECURITY SYSTEM AND ICT EQUIPMENT FOR THE DEPED-CAR REGIONAL OFFICE with the sum One Million Pesos (P 1,000,000.00) being the Approved Budget for the Contract (ABC). Specifically, the ABC for LOT 1 is Five Hundred Fifty-Five Thousand (P 555,000.00);**
