CONTRACT AGREEMENT

THIS AGREEMENT, made this OCT 25 2024, 2024 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

C & E: PUBLISHING INCORPORATED with a principal office address at No. 51 P. De La Cruz St. San Bartolome, Novaliches, Quezon City represented by its

JOSE S. GOMEZ herein referred to as the **"SUPPLIER"**

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly **"REBIDDING OF THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2024 SUPPLEMENTARY LEARNING RESOURCES (SLRs) TO THE SCHOOL LIBRARY HUBS UNDER LOTS 2, 3, 4, 8, 14, 15, AND 16 FOR DEPED-CAR - Lot 4"** and has accepted a Bid by the **"SUPPLIER"** for the supply of those goods and services in the sum of **TWO MILLION EIGHT HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FORTY-SIX PESOS (P 2,811,746.00) only**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **REBIDDING OF THE SUPPLY AND DOOR-TO-DOOR DELIVERY OF FY 2024 SUPPLEMENTARY LEARNING RESOURCES (SLRs) TO THE SCHOOL LIBRARY HUBS UNDER LOTS 2, 3, 4, 8, 14, 15, AND 16 FOR DEPED-CAR - Lot 4** and construed as integral part of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - Technical Specifications;
 - General and Special Conditions of Contract; and
 - Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

3. The contract duration or completion period shall be within **Sixty (60) calendar days upon receipt of Notice to Proceed;**
4. In consideration for the sum of **TWO MILLION EIGHT HUNDRED ELEVEN THOUSAND SEVEN HUNDRED FORTY-SIX PESOS (P 2,811,746.00) only** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid. Attached is a faithful reproduction of the BAC-TWG Arithmetical Evaluation indicating the Description of items, Unit price, and Quantity/unit of *the said goods and services included in this contract made an integral part hereof by incorporation as "Annex A"*.
5. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.


