WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly "SUPPLY AND DELIVERY OF TABLETS FOR FLEXIBLE LEARNING OPTIONS UNDER ALTERNATIVE DELIVERY MODE (ADM) - LOT 1 FOR DEPED-CAR" and has accepted a Bid by the "SUPPLIER" for the supply of those goods and services in the sum of ONE MILLION TWO HUNDRED FORTY- TWO THOUSAND SEVEN HUNDRED PESOS (P 1,242,700.00) Only;


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read SUPPLY AND DELIVERY OF TABLETS FOR FLEXIBLE LEARNING OPTIONS UNDER ALTERNATIVE DELIVERY MODE (ADM) LOT 1 FOR DEPED-CAR and construed as integral part of this Agreement, viz.:
 - Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
