- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. The contract duration or completion period shall be within 60 Calendar days from the date of receipt of the Notice to Proceed;
- 4. In consideration for the sum of FIVE MILLION FOUR HUNDRED THIRTY- FIVE THOUSAND THREE HUNDRED TWENTY PESOS (P 5,435,320.00) or such other sums as may be ascertained, "SUPPLIER" agrees to provide the goods and services in accordance with his/her/its Bid. The specifications the book title, quantity and unit price is contained in the TWG bid evaluation report. (attached is a copy of the bid evaluation marked as "Annex A" to form part of this contract)
- 5. WHEREAS, the total number of learning resources shall be equally divided and delivered to the 11 Recipient School Library Hubs (11 SLH ÷ total no. of LM);
- 6. The SUPPLIER shall be liable for LIQUIDATED DAMAGES for the delay in its performance in the amount equal to one-tenth of one percent (0.001) of the cost of the goods scheduled for delivery for every day of delay until the goods are finally delivered and accepted by the PROCURING ENTITY. DepEd Shall deduct the liquidated damages from any money due or which may become due to the Supplier, or collect from any warranties or securities posted by the Supplier, whichever is convenient. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, the Procuring Entity may rescind or terminate the contract, without prejudice to other courses of action and remedies available under the circumstances.
- 7. The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
