CONTRACT AGREEMENT

THIS AGREEMENT, made this FEB 13 2025 day of 2025, 2025 between:

DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (DEPED- CAR), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address at Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

STA. BARBARA PRINTSHOP AND GENERAL MERCHANDISE with a principal office address at Zone 2 Tuliao Sta Barbara, Pangasinan represented by its proprietor, **ISAGANI L. ICO**, herein referred to as the **"SUPPLIER"**

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly **"SUPPLY, PRINTING, AND DELIVERY OF FY 2025 SELF LEARNING MODULES (SLMs) WITH 3 LOTS IN DEPED-CAR Lot 2"** and has accepted a Bid by the **"SUPPLIER"** for the supply of those goods and services in the sum of **ELEVEN MILLION ONE HUNDRED SEVENTY ONE THOUSAND FOUR HUNDRED SIXTY FIVE PESOS AND FIFTY SEVEN CENTAVOS (P11,171,465.57)**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read **SUPPLY, PRINTING, AND DELIVERY OF FY 2025 SELF LEARNING MODULES (SLMs) WITH 3 LOTS IN DEPED-CAR Lot 2** and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

- 3. The contract duration or completion period shall be within **Within ninety (90) calendar days upon receipt of the Notice to Proceed ;**
- 4. In consideration for the sum of **ELEVEN MILLION ONE HUNDRED SEVENTY ONE THOUSAND FOUR HUNDRED SIXTY FIVE PESOS AND FIFTY SEVEN CENTAVOS (P11,171,465.57)** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the goods and services in accordance with his/her/its Bid; The items, description quantity and unit price are indicated in the arithmetical evaluation made by the TWG;

The DepEd- CAR agrees to pay the above-mentioned sum upon full delivery of the above listed items.
