DEPARTMENT OF EDUCATION- CORDILLERA ADMINISTRATIVE REGION (**DEPED- CAR**), a government agency duly organized and existing under the laws of the Republic of the Philippines with principal address *at* Wangal La Trinidad, Benguet represented herein by ESTELA P. LEON- CARIÑO EdD, CESO III, Director IV/ Regional Director referred to as the **"PROCURING ENTITY"**

GAP IMPORT AND EXPORT CORPORATION with a principal office address at Warehouse 5 Phase 2 Century Commercial Complex, Paliparan Road, Brgy. Salawag Dasmariñas City, Cavite represented by its proprietor, **MARK LYNDON B. DECENA**, herein referred to as the "**SUPPLIER**"

WITNESSETH

WHEREAS, the Entity invited Bids for Certain goods and ancillary services, particularly "SUPPLY AND DELIVERY OF TABLETS FOR FLEXIBLE LEARNING OPTIONS UNDER ALTERNATIVE LEARNING SYSTEM - LOT 2 FOR DEPED-CAR" and has accepted a Bid by the "SUPPLIER" for the supply of those goods and services in the sum of EIGHTEEN MILLION TWO HUNDRED SEVEN THOUSAND PESOS (†18,207,000.00) Only;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively as are respectively assigned to them in the Conditions of Contract hereinafter referred to;
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read SUPPLY AND DELIVERY OF TABLETS FOR FLEXIBLE LEARNING OPTIONS UNDER ALTERNATIVE LEARNING SYSTEM LOT 2 FOR DEPED-CAR and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. The contract duration or completion period shall be within Ninety (90) calendar days upon receipt of Notice to Proceed;
- 4. In consideration for the sum of **EIGHTEEN MILLION TWO HUNDRED SEVEN THOUSAND PESOS** (**P18,207,000.00**) **Only** or such other sums as may be ascertained, "**SUPPLIER**" agrees to provide the following goods and services in accordance with his/her/its Bid:
