

CONTRACT AGREEMENT

THIS AGREEMENT, made this JUN 01 2022 day of _____, _____ between **DEPARTMENT OF EDUCATION-CORDILLERA ADMINISTRATIVE REGION (DepEd- CAR) Regional Office**, Wangal, La Trinidad, Benguet (*hereinafter called the "Entity"*) and **GAP IMPORT AND EXPORT CORPORATION**, Warehouse 5 Phase 2, Century Commercial Complex 394 Paliparan Rd. Brgy. Salawag, Dasmariñas, Cavite (*hereinafter called the "Supplier"*).

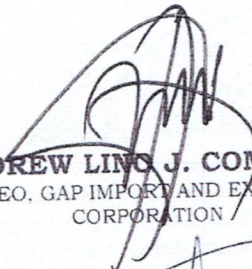

A warranty security shall be required from the contract awardee for a minimum period of three (3) months, in the case of Expendable Supplies, or a minimum period of one (1) year, in the case of Non-expendable Supplies, after acceptance by the Procuring Entity of the delivered supplies. The obligation for the warranty shall be covered by either retention money in an amount equivalent to five percent (5%) of the contract amount, or a special bank guarantee equivalent to five percent (5%) of the total contract price. The said amounts shall only be released after the lapse of the warranty period or, in the case of Expendable Supplies, after consumption thereof: Provided, however, That the supplies delivered are free from patent and latent defects and all the conditions imposed under the contract have been fully met.

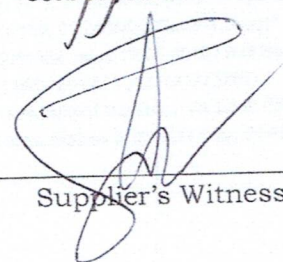
