1. In view of the need for continuous professional development, DepEd – CAR has availed of the Project Synergy Professional Development Program in collaboration with the Ramon Aboitiz Foundation Inc.(RAFI) and City Savings Bank.
2. The program which combines the principles of organizational development consulting and adventure – based programming to enhance leadership skills, team building , and character building is being conducted by RAFI at the Kool Adventure Camp in Balamban, Cebu.
3. The region’s participation to the said program will be in two batches of thirty (30) participants per batch. The first batch which will be held on October 20 – 22, 2015 will be participated in by the RD, ARD, RO Chiefs and OIC Chiefs of divisions, selected RO personnel, SDS and ASDS.
