Relative to the Program Support Funds (PSF) for the implementation of the National Learning Camp (NLC) downloaded to Regional Offices (ROs) for the payment of meal expenses of teacher-volunteers during the End-of-School-Year (EOSY) break for SY 2022-2023, ROs are directed to facilitate the immediate payment of the aforesaid meal expenses due to teachers who rendered service.

Apparently, a total of **229,036** teacher-volunteers rendered service. However, based on the NLC PSF utilization report from the ROs as of November 3, 2023, only a total amount of **Php821,217,511.47** has been disbursed which is much lower than the expected amount to pay for the abovementioned teacher-volunteers.

To ensure efficient utilization of the said PSF, this Office requests all ROs to **facilitate the immediate payment of meal expenses for the concerned teachers not later than November 30, 2023**, and provide guidance to schools division offices (SDOs) for the compliance of teachers of required supporting documents.
