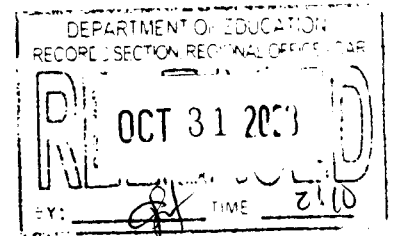

**ADDENDUM AND CORRIGENDUM TO RM NOS. 564 AND 435, S. 2023 (CONDUCT OF GOVERNMENT PROCUREMENT REFORM ACT TRAINING)**

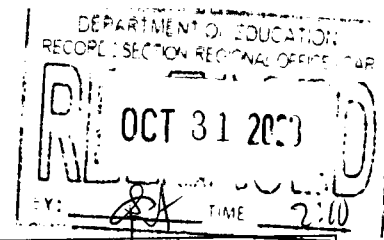
