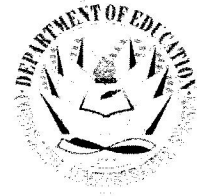
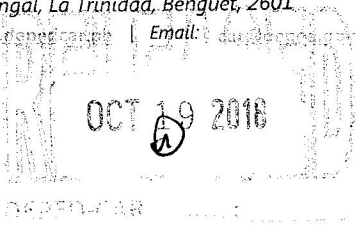

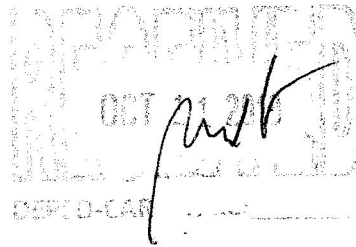

This is in reference to our previous communication dated July 24, 2018 regarding our request for a fully accomplished LRN which is due on October 5, 2018. In consideration to the aftermath brought by Super typhoon Ompong which affected some municipalities and provinces in the region, the Regional Program Management Office of the Pantawid Pamilya Program has extended the deadline of collection of the fully accomplished LRN form on or before November 28, 2018.

With this, may we respectfully request your good office for your assistance and support for the information dissemination of the said collection date to ensure the completion of our request.

May we also inform you that the Regional Program Management Office has requested the National Program Management Office for the imposition of NAC Resolution No. 26 Series of 2015 "Amendment to NAC Reso 13: Handling of Compliance Verification in Cases of State of Calamity, Disaster, Complexity and other Exceptional Cases" for Period 4 2018 Compliance monitoring (August-September 2018). Said NAC resolution is being requested in case a place is affected by state of calamity, disaster and complex emergencies.


This is in relation to the declaration of President Rodrigo Roa Duterte placing Regions I, II, III and the Cordillera Administrative Region (CAR) under state of calamity due to the aftermath of Typhoon Ompong through Proclamation No.593. In effect, all Pantawid Pamilya partner beneficiaries who are being monitored for education in the Region will be treated as compliant in educational condition for Period 4 (August-September) 2018.
