TRAINING OF CAREER ADVOCATES FOR GRADE 11 AND GRADE 12 CAREER GUIDANCE IMPLEMENTATION

To: **Schools Division Superintendents**

1. The mass trainings of teachers and career advocates for the implementation of grade 11 and grade 12 career guidance program were conducted last November 27-29, 2017 and December 4-6, 2017 respectively.
2. The Education Support Services Division (ESSD) has scheduled another training for career advocates who were not able to attend the two trainings which were conducted last November and December, 2017. The training will be conducted at the Ecolodge, Magsaysay Avenue, Baguio City on January 23-25, 2017.
