



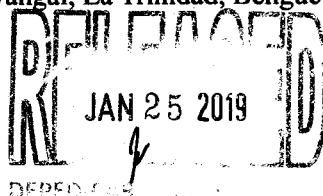

2019 CARAA MEET SCREENING AND ACCREDITATION OF ATHLETES, COACHES AND CHAPERONS

To: Schools Division Superintendents

1. The 2019 Cordillera Administrative Region Athletic Association (CARAA) Meet will be hosted by the Province of Apayao on February 27-March 3, 2019.
2. The Regional Screening and Accreditation Committee (RSAC) shall perform the duties and functions, the following:
  - a) Evaluate and verify the authenticity of the documents of athletes, coaches, assistant coaches and chaperons before and during personal interviews;
  - b) Accredite qualified athletes, coaches, assistant coaches and chaperons;
  - c) Consider replacements for qualified athletes during the period of screening;
  - d) Issue photo galleries of qualified for every schools division to the tournament managers;
  - e) Re-check and monitor the fielding of athletes during actual competition based on the gallery submitted to the tournament managers;
  - f) Appellate jurisdiction on decisions by the RSAC.
3. One of the required documents to be submitted during the 2019 Palarong Pambansa is the Photo Album. The content of the photo album are the athletes, coaches, assistant coaches and chaperons' profiles. The picture (size-1.5 X 1.5) should be clean and not blurred and the attire will be the delegation or division uniform.
4. As agreed during Planning Conference for Regional Sports last January 11, 2019, the documents review will be on February 20-22, 2019, and interview of athletes, coaches, assistant coaches and chaperons shall be on February 23-25, 2019. The travel time for all RSAC members will be on February 19, 2019. The billeting area for RSAC members should be preferably with an adjacent spacious area/hall for the documents.
