



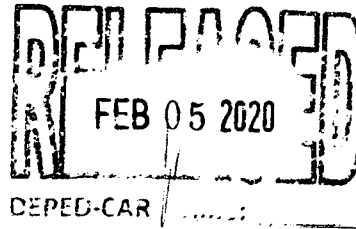



SUSPENSION OR POSTPONEMENT OF THE 2020 CARAA, OTHER REGIONAL EVENTS, AND CAR'S PARTICIPATION TO THE 2020 NSPC, NFOT and NSTF

To: **Regional Functional Division Chiefs**
Schools Division Superintendents
Public and Private Elementary and Secondary School Heads
All Divisions
All Others Concerned

1. Pursuant to DepEd Memorandum No. 15, series 2020, titled **First Set of Policy Directives of the DepEd Task Force NCOV**, the 2020 Cordillera Administrative Region Athletic Association Meet (CARAA), CAR'S participation to the National Schools Press Conference and National Festival of Talents, and other Big Regional Events involving learners and/or teachers requiring travel and congregation of various schools, divisions, and/or regions this **month of February are suspended or postponed until further notice.**
2. The suspension of such activities is one of the measures for the prevention and control of the 2019-Novel Coronavirus Acute Respiratory Disease (nCoV ARD) upon advice of the Department of Health (DOH) and in support to government efforts to contain the spread of the virus.
3. Other suspended/postponed regional event that is supposed to be conducted this February 2020 is the Advocacy Caravan on CyberSafety and CyberREADi Schools cum Launching of Project #IamDepEdCAR – February 7, 2020;
4. The Department shall periodically evaluate the necessity of suspending such national participation and conduct of regional activities and shall release the necessary advisories or memoranda relative to this.
5. Immediate dissemination and compliance of this Memorandum is desired.
