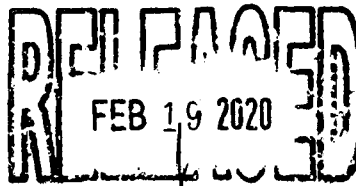

CONFERENCE ON THE IMPLEMENTATION OF THE LAST MILE SCHOOLS IN NORTH LUZON

TO: **Regional Office Employees

All Others Concerned**

1. The Office of the Undersecretary for Administration (OUA), in cooperation with the Indigenous Peoples Education Office (IPsEO) and the Disaster Risk Reduction and Management Service (DRRMS) will be conducting a **Conference on the Implementation of the Last Mile Schools in North Luzon on March 2-3, 2020 in Teachers' Camp, Baguio City**, thus, participants listed in **Annex A** are requested to attend the Conference.
2. This Conference will be a venue for education managers at the Regional and Division Level to level-off on the directions and challenges in the Last Mile Schools Program given the conditions and context specific to North Luzon. This also hopes to consolidate existing practices in addressing Last Mile Schools concerns to ensure the alignment of all efforts across all governance levels and the sustainability of directions and specific steps to be agreed upon.
