

Subject: **REGIONAL FACILITATORS' TRAINING FOR ADDITIONAL PROVIDERS OF MENTAL HEALTH (MHPSS) FOR STUDENTS AND PERSONNEL AFFECTED BY DISASTERS**

1. The DepED, Regional Office through the Education Support Services Division and Curriculum and Learning Management Division, will conduct the Regional Facilitators' Training for Additional Providers of Mental Health (MHPSS) for Students And Personnel Affected By Disasters on March 22-23, 2017 at NEAP-R, DepED-CAR.
2. The training aims to:
 - a. Equip the participants with basic knowledge, proper skills and attitude in the promotion of Mental Health and the provision of Emergency Psychosocial Support to the affected population
 - b. Broaden the roles and functions of the participants in assisting students in case of adverse life events such as epidemics and disasters; and
 - c. Establish a Functional System for the provision of Emergency Psychosocial Support for students and personnel during disasters and emergencies
3. The participants are Education Program Supervisor in charge of Guidance (CID), Health Personnel in-charge of Psychosocial Stress Debriefing and (1) Guidance Counsellor/Designate.
4. The travel expenses of the participants shall be charged against local funds of the SDOs and participants from the six divisions namely; Abra, Apayao, Ifugao, Kalinga, Mt. Province and Tabuk City are entitled for free board and lodging while participants from the Schools Divisions of Baguio and Benguet are entitled for free meals and snacks during the two-day training.
