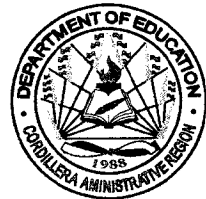



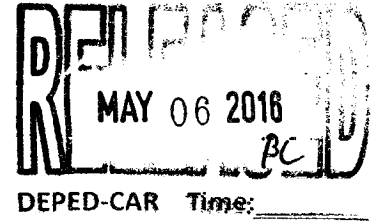

COUNCIL**



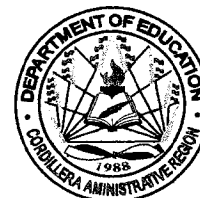
1. In relation to the Consultation among DepEd CAR key persons on child protection concerns such as child abuse, bullying, CAR, and CICL (Regional Memorandum No. 110 s. 2016) conducted on April 29, 2016 where one of the objectives is the creation of a Regional Child Protection Committee, the participants agreed on the composition of the DepEd-CAR Regional Child Protection Council or DepEd-CAR RCPC.
2. The composition of the Regional Child Protection Council is agreed to be as follows:
 - a. The Officers
 - Regional Director as Chairperson
 - Assistant Regional Director as Co-Chairperson
 - Representative per Sector as Vice Chairpersons – selected by the members of each sector
 - b. The Regular Members
 - The Legal Unit
 - Regional Office EPS for Edukasyong Pagpapakatao
 - All SDO representatives (7 per Division)
 - c. Honorary Members
 - LGU Representatives (per division)
 - RO DSWD Representative – to be designated by the DSWD Regional Director, preferably the officer in charge of child protection
 - RO PNP Representative – to be designated by the Regional Director

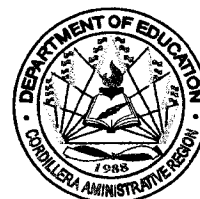

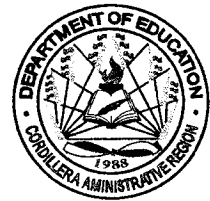

4. The main function of the Regional Child Protection Council is to recommend and support policies, programs, projects and activities on child protection, as well as ensure its monitoring and evaluation.
5. The Council en banc shall have a regular meeting at least twice in a School Year, and the Officers may have additional special meetings as deemed necessary;
6. The funds for the meetings will be charged to the regional fund while transportation and accommodation shall be charged to local funds.
7. The Division Offices are encouraged to adopt their Division Child Protection Committee.
