## 1st CALL FOR SUBMISSION OF RESEARCH PROPOSALS FOR THE 2018 BERF FUNDING

- 1. Pursuant to DepEd Order No. 16, s. 2017 entitled "Research Management Guidelines", this Office calls for the submission of research proposals (action research and basic research) for funding under the CY 2018 Basic Education Research Fund (BERF).
- 2. This is also to reiterate that all research proposals submitted to the division offices shall be **reviewed and screened** by the Division Research Review and Evaluation Committees (DRREC) before endorsing to the Regional Research Review and Evaluation Committee (RRREC) for approval, thru the Policy, Planning, and Research Division (PPRD) on or before *May 22, 2018*.
- 3. All proponents of approved proposals will be notified for orientation.
- 4. Research proposals not accommodated for funding last December 2017 due to scarcity of funds may be resubmitted for funding this CY 2018 if necessary. Moreover, researchers who conducted their researches even without the BERF to improve the teaching-learning process are highly commended.
