

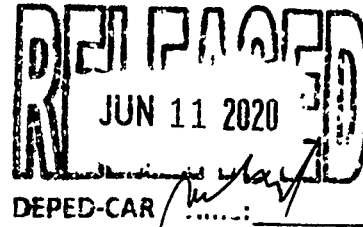

**ONLINE CONSULTATION MEETING ON THE PROPOSED ACTIONS FOR THE


