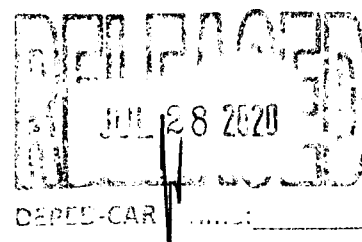

**PROVISION OF GUIDANCE TO SCHOOLS DIVISION OFFICES
IN THE IMPLEMENTATION OF BLENDED/DISTANCE LEARNING**

1. Pursuant to DepEd Memorandum DM-CI-2020-00152 from Undersecretary Diosdado M. San Antonio dated July 20, 2020 and in view of the need to ensure that the Self Learning Modules (SLMs) are compliant with the standards set by the Bureau of Learning Resources, there are still SLMs which have not been fully quality-assured by the central office Conformance Review Teams as of date.
2. Attached in Enclosure 1 are the number of available modules uploaded by the Central Office through the Regional Office and will be shared to all the SDOs through the EPS In-charge of LRMDS.
3. The downloaded funds to support and provide Learning Resources for the Implementation of the BE-LCP shall prioritize printing or reproduction of the available SLMs. Contextualized MELC-based modules may only be printed in the absence of available Central Office uploaded SLMs.
4. To provide guidance to the SDOs in ensuring that all learners are provided the necessary learning materials to support Blended/Distance Learning Delivery, the following strategies are recommended, to wit:
 - A. Use of the map of the learning resources needed for each sub-category of Distance Learning Delivery Modality (Ref.:DM-CI-2020-00162 or the Suggested Strategies in Implementing DLDM for SY 2020-2021)

2. MELCs-mapped DepEd Textbooks/LMs shall be used as learning resources for all DLDM. When used with activity sheets and learning plans, MELCs-mapped DepEd Textbooks/LMs may substitute printed SLMs.
3. Parent's/Learning Facilitator's guide will be used in all sub-categories of the DLDM.
4. Other textbooks/LMs and Teacher-made videos/modules may supplement the required learning resources for each DLDM.
5. While all sub-categories of DLDM are appropriate for all Grade Levels when managed by a teacher/learning facilitator, those in green colors are the priority grades to do the specific DL, in cases where resources are limited.

- C. Use of Videos and Audios to complement modular distance learning delivery which will require:
- Inventory of existing lessons converted to audio and video formats
 - Pool of teachers to develop audios and videos which are still lacking based from inventory
 - Quality assurance of audios and videos
 - Partnership with TV and Radio networks for educational air time
 - Creation of You Tube channel for educational “courses”
 - Utilization of flash drives and transistor radios to store audio lessons
- D. Utilization of the Special Education Fund in coordination with the LGUs to support the SDO’s Learning Continuity Plan;
- E. Pooling of unobligated 2019 MOOE funds of the RO and SDO levels and use of not more than 30% of the School MOOE to augment allotment gaps for reproduction;
- F. Grouping of learners according to:
- Access to devices/gadgets/connectivity; or
 - Preferred modality
- G. In big schools, grouping of teachers per grade/level to conform to the learners’ preferred modality/ies;
- H. In-house printing of Self-learning modules;
- I. Downloading of fund to schools as cash advances so that schools can address specific modular needs and strategize based on the results of their LESF;
- J. Partnerships with volunteer teachers or community learning facilitators to assist in the delivery of learning resources and in facilitating task accomplishments of learners;
- K. Strengthening Partnerships with external stakeholders;
- L. Other strategies which may be feasible to the context of the Divisions and the schools.

4. Immediate and widest dissemination of this memorandum is desired.
