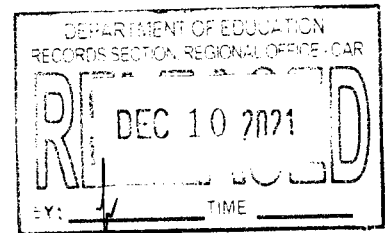

**ADDENDUM AND CORRIGENDUM ON THE CONDUCT OF TRAINING OF
TEACHERS FOR THE DEPED-CAR LEARNING COMMUNITY BUILDERS**

1. Relative to the issued Regional Memorandum No. 590, s. 2021, the conduct of the **Training of Teachers for DepEd CAR Learning Community Builders** shall be rescheduled due to non-availability of training materials and resource persons.
2. The training shall cover **February 22 to 25, 2021** of which participants (Enclosure 1) are expected to arrive at the National Educators Academy of the Philippines (NEAPR) on February 22, 2021 (Day 0) to adhere to scheduled activities in the training matrix, having the first meal as dinner of Day 0 and last meal as PM snack of Day 3.
3. Respective SDOs shall provide full assistance and prior arrangements to the participants in strict compliance to required travel documents by the Local Government Unit as applicable to their route and in addition to the Entry Requirements of the training venue.
4. Pre and post training expenses shall be charge^d to local funds, while training expenses shall be charged against Human Resource Development Fund, both subject to existing accounting and auditing rules and regulations.
