

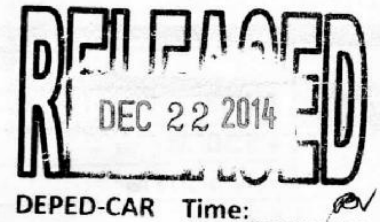





Subject: **CULMINATING PROGRAM OF THE TRAINING-WORKSHOP ON LEADING AND  
MANAGING THE K TO 12 CURRICULUM IMPLEMENTATION**

1. With reference to Regional Memo No. 155, s. 2014, TRAINING-WORKSHOP ON LEADING AND MANAGING THE K TO 12 CURRICULUM IMPLEMENTATION, a **Culminating Program** will be held on January 13, 2015 at Teachers Camp. Baguio City.
2. The Culminating Program aims to provide a venue for the exchange of good practices and experiences in the implementation of re-entry projects relevant to leading and managing the K to 12 curriculum implementation and to affirm their commitment towards the implementation of the K to 12 curriculum.
3. Participants in the training are superintendents, assistant superintendents, education program supervisors, public schools district supervisors and all public elementary and secondary school heads.
4. All participants shall bring outputs of Re-entry Plans and report of its implementation.
5. Transportation and other incidental expenses of participants shall be charged to the local funds of their respective offices while board and lodging of participants and training management team (resource speakers, facilitators), miscellaneous and other incidental expenses relative to the training shall be charged to the Regional Office funds subject to the usual accounting and auditing rules and regulations.
6. The registration shall start at 4:00 P.M. on January 12 at the venue. The first meal to be served will be dinner of January 12 and the last meal will be dinner on January 13. A schedule of activities is attached (see *Enclosure 1*).
